TANRAIL Investments Limited intends to seek for strategic partner to invest in the development of TRC rail transport services including Jamatini Area, within the city and region of Dodoma.
- 2.TANRAIL Investment Limited is, by virtue of section 182 (2) of the Companies Act No. 12 of 2002 looking for prospective investor (s) towards Development of Rail Transportation services Centre who intends to support rail transport services operated by TRC. The developed designs concept by an Investor (s) shall be approved by the TANRAIL Investments Limited. The rail transport services centre will entail the development of five (5) projects categorized into five (5) Lots named hereunder:
 - Lot 1: Business Hotel Project
 - Lot 2: High End Four Star Hotel Project;
 - Lot 3: Shopping Mall & Recreation Park Project;
 - Lot 4: Office Building (s) Project;
 - Lot 5: Conference Facility and Multipurpose Halls.

The TANRAIL Investment Limited is among other things, mandated to manage and develop 52 acres of land located at Dodoma City Centre in Tanzania commonly known as Jamatini area within the scope of supporting TRC rail transport services. The area is located at the city centre and about 6km from the new Dodoma bus terminal and 12km from Msalato International Airport. The area is easily accessible from both Dodoma Highway (8 129) and Kikuyu Avenue Road.
- 4. The purported development will be implemented through Joint Venture Agreement (JVA) to be entered between the TANRAIL Investments Limited and the qualified Investor(s). The investor will be required to assume primary responsibility in the designing, financing, developing, marketing and operating the proposed project on that area.
